LEGISLATIVE REPORT

HB177 passed. Allowing schools to use block chain technology.

House Primary & Secondary Education Committee has passed SB229

The bill will temporarily extend the blended learning filing deadline to April 2022. Schools can adopt a resolution for people who request online learning. Quarantined students could be in the online learning program. Prohibit use of chronic absenteeism on state report card. Require ODE to calculate on adjusted grade, add to Superintendents and community school to State Report Card Committee. Exempt online learning school from emergency plan. Financial literacy half credit added, could be taught in Social Studies course.

### Sponsoring testimony

HB403 – Reports filed by Superintendent if employee retires or resigned due to evaluation/threat of discipline.

SB248 – Require a moment of silence each day in schools.

Senate & News Committee

HB126 – 3<sup>rd</sup> Hearing – Property valuation complaint or counter complaint must let them know in writing. OSBA/OASBO/BASA are all providing opposition testimony.

#### House Criminal

HB99 – amended and passed. Overrule decision in Gabbard vs. Madison – Were allowed to carry guns into the school with the minimum amount of training. Armed within a school safety zone and establish safety.
